Amazing Spaces Storage Centers Donation & Sponsorship Application

Eligibility Requirements:

• Must be a non-profit group or organization with current tax-exempt status under Section 501(c)(3) of the Internal Revenue Code; or that operate as an entity of a recognized government agency, as demonstrated by primary funding and documented by a letter from that agency.

The following organizations are also eligible to receive funding from Amazing Spaces:

- Recognized government entities: state, county and city agencies, including law enforcements,
- fire departments, as well as volunteer fire departments
- K-12 public schools/districts, charter schools, community/junior colleges, state colleges and universities.
- Churches and other faith based organizations with proposed projects that address and benefit the needs of the community at large. Examples of such projects include:
 - Food banks
 - Shelters
 - Job skills training

Please note that all storage donation requests must have a specific start and end date.

Funding Exclusions:

Funding requests for any type of initiative included in the list below are typically ineligible to receive funding through Amazing Spaces. Please note: in certain circumstances, exceptions may apply.

- Contests or pageants
- Political causes, candidates, organizations or campaigns
- Advertising, film or video projects
- Program advertising or marketing venues
- Individuals
- Association memberships
- Organizations whose services are limited to its members
- Organizations or programs that are based outside the communities we serve or outside the U.S. (this does not include the recipients of their efforts).
- Institutions that by virtue of their charters, programs, or policies serve a small or restricted segment of the community.
- Organizations or fund-raisers that intend to retain any portion of funding for profit.

Required Documentation for Consideration:

- Filled out application for donation/sponsorship (see page 2)
- Information about the background and history of the organization
- Tax Identification Number
- Copy of the federally issued statement of your organization's 501(c)3 status.
- Applications must be submitted a minimum of 30 days before the event/funding is needed. The review process for any request is up to 30 days.
- All information must be emailed or mailed to Amazing Spaces' corporate headquarters.
